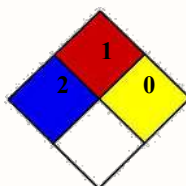

May also affect blood, metabolism and urinary system. Ingestion: Causes digestive (gastrointestinal) tract irritation with nausea, vomiting, and diarrhea. May affect behavior (altered sleep time, change in motor activity), cardiovascular system (heart rate), and the brain. May also affect the blood and may cause tumorigenic effects. Chronic Potential Health Effects: Prolonged exposure may cause adverse reproductive effects. Laboratory experiments on animals have resulted in mutagenic effects. Prolonged exposure or exposure at high concentrations may cause eye damage.
